## 21<sup>st</sup> ICSMGE in Vienna (June 2026)

**CAPG will host a dedicated 30-minute session showcasing Outstanding Geotechnical Projects. This session will feature 5 to 6 selected presentations, each approximately 5 minutes in length.**

### **Preparation Timeline:**

**Stage 1 – Call for Contributions (June 2025):** *Corporate Associates (CAs) interested in presenting are invited to contact the CAPG Chair directly. Submissions should include a brief description of the proposed project and highlight key elements demonstrating excellence in:*

- ✓ *Innovation*
- ✓ *Sustainability*
- ✓ *Advancements in geotechnical engineering practice*

**Stage 2 – Jury Formation (June–August 2025):** *A selection committee will be established to review and evaluate submissions. The jury will consist of at least six members, either official CAPG representatives or nominated delegates from CA member companies. This committee will oversee the voting process and secure the review of the proposed presentations.*

**Stage 3 – Evaluation (September 2025):** *Projects will be assessed based on:*

- ✓ *Innovation*
- ✓ *Sustainability*
- ✓ *Addressed challenges*
- ✓ *Additional criteria to be defined by the jury*

**Stage 4 – Announcement (October 2025):** *Selected projects will be officially announced in October 2025 and CA members will be requested to prepare their presentations.*

**Stage 5 – Presentation Development (November 2025 – February 2026):** *Selected CAs will prepare their presentations. A draft version should be submitted by December 2025 for review and feedback. Final presentations must be completed by February 2026.*

**Stage 6 – Presentation at ICSMGE (June 2026):** *The selected projects will be presented live during the Vienna conference. Additional high-quality submissions may also be featured on the CAPG section of the ISSMGE website, providing extended visibility for CA member contributions.*
